3 Background info about the DC

The Dynamic Coalition on Child Online Safety (DC COS) was established at the 2nd IGF in Rio de Janeiro in 2007 by organizations working with and for children and youth with ECPAT int. as the chair and Stiftung Digitale Chancen as the co-chair. The objective was to establish a dialogue among stakeholders from various backgrounds and address fundamental and practical issues impacting on child safety on the Internet.

Since 2007, there have been significant evolutions in the scale and nature of opportunity, risk and harm to which children are exposed in digital environments, thus the relevance of the group's work continues to expand and grow. When in 2021 the United Nations Committee on the Rights of the Child adopted General Comment # 25 on children's rights in relation to the digital environment the members decided to strengthen their focus on children's rights and renamed the DC to **DC on Children's Rights in the Digital Environment**

In 2024, the position of Head of Child Protection and Technology at ECPAT was vacant and with it the chairmanship of the DC. So, the Digital Opportunities Foundation, Germany took over the chairmanship of the DC temporarily.

4 Key objectives

- To ensure a safer and more secure online environment for children and youth
- To establish on-going exchange of experiences between all stakeholders
- To encourage procedures for the improvement of legal regulations as well as self-regulation instruments towards child safety online
- To strengthen efforts on all levels to fight child sexual abuse images of all kind
- To strengthen efforts for the empowerment of children and youth themselves
- To discuss how to ensure that all tools such as web-based reporting mechanisms or age verification solutions restricting access for younger users to certain types of content and services provided to children such as awareness raising campaigns or educational content through digital platforms are employed reasonably



- To ensure that the needs of children as users are respected in the development and provision of new services and applications online
- To create a platform for child rights agencies and freedom of expression advocates to dialogue on issues of mutual concern.

Description

The Internet of Things offers many opportunities to make our everyday lives more convenient, safer and more efficient. Due to the advancing use cases, digital applications will be omnipresent in the future and also offer the benefit of being at our side almost unnoticed. However, this can also result in risks, such as unwanted data processing, the provision of information that may be inappropriate or even harmful to individuals or the initiation of processes that are based on false assumptions. These risks can be countered by identifying the users. If the devices in the surroundings know who the user is, the Internet of Things can work adequately according to their needs and with specific measures and serve the user. One area of identification is the verification of age or assignment to an age group. Knowing this, smart speakers would, for example, generate information in child-friendly language for very young users or sensors that check whether older residents have fallen and may be lying helplessly on the floor would not be triggered incorrectly if a child is playing on the carpet in the living room.

According to the DC IoT Internet of Things Good Practice aims at developing IoT systems, products, and services taking ethical considerations into account from the outset, in the development, deployment and use phases of the life cycle, thus finding an ethical, sustainable way ahead using IoT to help to create a free, secure and rights enabling based environment: a future we want.

DC CRIDE based their understanding on the findings of the Global Age Assurance Standards Summit held with about 700 participants from around the world in Manchester in April 2024. The Summit's Communiqué sets out the assumption that age assurance is a way to create a safe environment for users of all ages where they can exercise their rights and securely enjoy also the benefits of new and emerging technologies.

5.3 Other processes

- DotKids Foundation is in continuous partnership with IWF through CleanDNS and is currently looking at developing graylists and proactive measures for keeping .KiDS a kids-best interest domain space. Also working with positive examples and showcasing good positive usage of the .kids domains encourage more positive usage.
- DotKids case study is part of the teaching module in the 2024-2025 Netmission Academy, an 8 week capacity building program for all APAC youth to learn about Internet Governance. The network of NetMission alumni and ambassadors, then share their knowledge gained to their local community and organize their own youth-led initiatives to inspire more youth to care about the Internet. NetMission. Asia provides a platform for young people in Asia with shared interests on Internet issues to connect, advocate and channel the ideas to the global policy dialogue. As part of the Government Advisory Committee capacity building, .kids was also used as a positive case study in part of a briefing done at the end of 2024 and also in Feb 2025 for delegates seeking to improve the Applicant Support Program as well as understand the needs and requirements of a community application.
